

ORDINANCE NO. 2023-01

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF SLOAN, IOWA BY AMENDING CHAPTER 21, SECTION 21.03 PERTAINING TO QUALIFICATIONS OF LIBRARY TRUSTEES

WHEREAS, Sloan Municipal Code, Chapter 21, §21.03 reads as follows: QUALIFICATIONS OF TRUSTEES. All members of the Board shall be bona fide citizens and residents of the City. Members shall be over the age of eighteen (18) years.

WHEREAS, the City Council has determined that it is in the best interest of the City of Sloan and the Sloan Public Library to amend Section 21.03.

WHEREAS, therefore the City Council of the City of Sloan, Iowa, proposes that Section 21.03 be amended as follows:

21.03 QUALIFICATIONS OF TRUSTEES. All members of the Board of Library Trustees shall be bona fide citizens and residents of the Sloan and Salix area. Members shall be over the age of eighteen (18) years.
